ABSTRACT

This article aims to analyze the application of the Wasatiya principle as a diplomatic strategy in resolving global conflicts, focusing on the implementation of moderation in international diplomacy. The method used is a descriptive literature review, with data sourced from international journals indexed in Scopus or DOAJ (2015-2024). The research findings indicate that the Wasatiya moderation principle is effective in reducing international tensions, creating an inclusive dialogue space, and achieving peaceful solutions. The application of this principle allows for the creation of an inclusive and constructive dialogue space, while avoiding confrontations that exacerbate conflicts. However, the main challenges faced include mistrust between countries and the imbalance of power in global diplomacy. These findings suggest that, despite these obstacles, the Wasatiya principle remains relevant and effective in creating sustainable peace in international diplomacy by promoting inclusivity and fair solutions for all parties involved.

In the midst of growing global tensions, the world faces a major challenge in resolving various international conflicts involving conflicting political, economic, and ideological interests (Grassiani et al., 2015; Ide, 2018). The phenomenon of polarization in international relations, both between countries and between groups within countries, leads to the emergence of cycles of violence and confrontation that are detrimental to world peace (Hegre, 2018). As this phenomenon develops, there is an urgent need to seek a diplomatic approach that is not only effective in easing tensions but can also facilitate a sustainable peace. One approach that can offer a solution in this context is Wasatiya, a principle of moderation that is rooted in Islamic tradition but has relevance far beyond religious boundaries (Bakir & Othman, 2017; Wani, 2016).

Wasatiya, which means "moderation" or "balance", emphasizes the importance of avoiding two extremes in decision-making, both in personal life and in international diplomatic contexts (Ibrahim, 2018). This principle supports the application of justice, inclusivity, and self-control in dealing with situations full of tension and differences. In international diplomacy, the application of Wasatiya offers an alternative to avoiding confrontational and

polarizing strategies that often exacerbate conflicts. In this context, the principle of moderation can be key to fostering dialogue, compromise, and peaceful solutions, which in turn can build long-term stability.

Historically, the Wasatiya principle has shown its effectiveness in resolving conflicts, with several concrete examples reflecting the values of moderation in the practice of diplomacy (A'la et al., 2023; Bakir & Othman, 2017). One of the most famous examples is the Hudaibiyyah Treaty in the 7th century, where the Prophet Muhammad chose peace over continuing the war, even though at the time the treaty seemed unfavorable to Muslims. In addition, the diplomacy of the Ottoman Empire, which managed to manage a multiethnic and multireligious empire with the principles of balance and moderation, shows how diplomacy based on the Wasatiya principle can maintain peace in the long run, even in very complex and tense situations.

However, the application of the Wasatiya principle in international diplomacy is not without challenges. One of the biggest obstacles is the partisan agenda that often pushes countries to put their national interests ahead of global peace. In addition, distrust between countries accumulated due to a long history of conflict is also a challenge in building constructive dialogue (Rød et al., 2024; Scheidel et al., 2020). Imbalances of power in the international arena, with large countries often dominating the negotiations, also make it difficult to reach a balanced and fair agreement (Grassiani et al., 2015; Hegre, 2018). Therefore, the application of the Wasatiya principle requires a commitment to inclusivity, sustainable dialogue, and justice in every aspect of international diplomacy.

This article aims to analyze the application of Wasatiya as a diplomatic strategy in resolving global conflicts, by examining its implementation in relevant practical cases. Through a descriptive analysis approach, this article will illustrate how this principle of moderation has been applied in international diplomacy and how it can help defuse tensions and build a more sustainable peace. Examining real-life examples of diplomacy broadens the understanding of the relevance and effectiveness of Wasatiya in contemporary diplomacy as well as providing insight into how this principle can be applied more broadly in addressing global diplomatic challenges.

METHODS
